3rd Phase major activities consolidated information as on December 2021 and action plan.

- > 33 Acers of land plan was got Approval from STRR authorities.
- > The developmental activities in the approved lands have been initiated.
- > Geological survey for water points were carried out.
- A bore-well has been drilled and got very good water yield (about 3.5inches).
- > The Electrical poles were erected and connections were taken.
- > The Transformer was installed.
- The Soil-Testing samples were sent to the laboratory for report for initiating developmental activities.
- > The marking for drain and roads were initiated.
- > The Site office is under construction.
- > The labour sheds were constructed.
- > Amenities works for labour were under progress.
